

PFIC Scientific Conference 2022 Health and Safety Policy and Waiver

By registering for and attending in-person the PFIC Scientific Conference 2022 in Pittsburgh, Pennsylvania, I agree to abide by all health and safety guidelines and recommendations established by state and local government agencies and officials, the PFIC Network and the event venues, including but not limited to, the Hyatt Regency Pittsburgh International Airport and conference room. This includes, but is not limited to, adhering to any requirements and restrictions during the event established by PFIC Network, the convention center and hotel venues. These requirements and restrictions may consist of completing and daily health screening, masking requirements, temperature checks, and other activities outlined in the Commitment to Care Statement (this statement will be updated regularly during the planning process as the state of Covid-19 changes). Remote attendees will not need to abide by these requirements and restrictions, but are asked to agree here in the event that you take advantage of the opportunity to change your registration to in-person.

I further agree that I will not attend the PFIC Scientific Conference 2022 in person if I become ill during the meeting, or am exposed to the COVID-19 virus within 14 days prior to the event or exhibit any symptoms of the COVID-19 virus prior to the event. Additionally, I understand that travel to and participation in events may increase the risk of exposure to COVID-19 and other communicable diseases.
